Vestry Meeting (Zoom)—May 18, 2023

Meeting started at 7:01 PM

- 1. Opening Prayer—Fr. Wand
- Motion to accept the minutes from April, 2023 with gratitude; 1st: Jude Winters; 2nd: Janet 2. Russello: all in favor
- 3. **Upcoming Events:**
 - a. Memorial Day May 29: Jill Graham
 - i. 10:00 Music and Gathering; 10:30 Parade to Monument; 11:00 Service; 11:30 Calvary Cemetery for laying of the wreath and gun salute; 11:30 Festivities at the Monument
 - ii. Fr. Wand will represent our Church
 - iii. Honoring: Tommy Brown last known soldier (Vietnam War) killed during the war from our area.
 - Installation of EM's. EV's and Altar Guild will be moved from June 4 to the Fall.

- 4. Financial Report: Rosemary Bezuidenhout
 - a. Monthly: OK
 - i. Income Donation: close to ½ of what we budgeted and its where we want it to be by Easter.
 - ii. Snow Removal $\frac{1}{2}$ of what we budgeted
 - iii. Preschool we have 7 students signed up for Fall.
 - b. Weekly: OK
 - i. Investment: (Church Foundation)
 - 1. We have not received our money yet but when it gets deposited we will have repaid ourselves what we borrowed to do parking lot.
 - c. Employee Retention Credit
 - i. To be done by Paychex they will do the paper work for us for a \$4000.00 fee and we would be entitled to receive \$22,311.00 in 6-9 months from the gov't,
 - ii. Finance Committee thinks we should do it but needs Vestry approval.
 - iii. Motion to approve Paychex to file the credit forms on behalf of our parish and authorize the payment of \$4000.00 to Paychex. 1st: Janet Russello, 2nd: Jim Geiger; all approved.

- d. Bequest to Parish from Ralph Painter
 - i. We were notified that Ralph Painter bequeathed \$25,000 to the Parish in his will.
 - ii. Finance Committee suggested we put the money, when we receive it, into the General Endowment Fund.
 - iii. The General Endowment Fund- we can withdraw from it with 2/3 vote approval from the Vestry and there are no restrictions.
- e. Motion to reaffirm the authorization of our Treasurer to move funds around from the various bank accounts to support our cash flow. 1st: Jude Winters; 2nd: Helen Dunlap; all in favor.

 - a. Jim, Phyllis, Janet, Helen—Super²⁷-duper thanks for so much
 - b. Dishwasher in Sexton House fixed.
 - c. Water filter to Sexton House installed: \$2700.00
 - d. Stove in undercroft fixed
 - e. Bill Diamond will be putting in electric for a meter for the well.
 - f. Received insurance check for rectory roof.
 - g. Gary Koerner will donate a higher toilet and grab bars for the Men's restroom in undercroft. Jim Geiger will replace the toilet

 - i. Cross Replacement will be \$9,775 with \$1000 insurance deduction. We will receive a check for \$8.775.
