1. Opening Prayer 7:02 pm - Fr. Wand
2. Brief Check-In by Vestry Members
3. Minutes from Previous sessions: Phyllis made the motion to accept the minutes as written, Barbara 2<sup>nd</sup>. All were in favor.
4. Fall Pledge Campaign results to date, actions to be taken-Joe Bardroff: 11 families have not submitted for pledge cards for next year. Total to date \$110,000. Reviewed List. Follow ups will be made.
5. Financial Report (see shared docs): Thanks to Rosemary and Dawn.
  - a. Phyllis made the motion to accept the November Financial report, Helen 2<sup>nd</sup>. All were in favor.
  - b. 2021 Budget Reviewed. Motion to Adopt the Budget as presented was made by Janet, 2<sup>nd</sup> by Helen. No discussion. All were in favor. Motion passed unanimously.
    - i. Pledge: of the pledges not yet received- about 12,000 that we could still expect.
    - ii. Income we are hopeful for-Sexton House Rental.
    - iii. PreSchool is anticipating Pre-School to resume in the fall.
    - iv. Staffing expenses- increase 1.5%
  - c. Bonus for Staff: Bonus's for 2019-Dawn: \$600; Sarah: \$150; Rick: \$125; Teachers: \$100 each for 2 teachers; Debbie: \$150 Fr Wand: \$300.  
**Bonus for 2020:** Dawn: \$500, Sarah \$150, Debbie: \$150. Teachers \$100 for each.
6. Christmas worship schedule- 14 interested in the 3pm service. 13 interested in 6pm service. 5 interested in the Christmas Day Service. We will hold all 3 services unless the Diocese gives a directive to close.

  - a. Collection—Donations: Updated figures for food pantry \$10,625 collected, amount disbursed \$9,500.
